1. What is revocation of a qualified certificate?

Certificate revocation is equivalent to the loss of certificate validity and **is permanent (irreversible**). It also results in the termination of the agreement concluded between the subscriber (the person for whom the certificate was issued) and Certum without reimbursement of the payment for the unused period.

This instruction describes the process of certificate revocation through the website and is intended for persons who do not have an account on <u>panel.certum.pl</u>

Tip: A qualified certificate is needed to create an electronic signature – which is why you will also encounter the term 'certificate' in the next steps of this instruction.

2. Steps of the revocation process

Start the revocation process by going to the website revoke.certum.eu, then select the option **Revoke** qualified certificate.



2.1. Steps for the certificate owner

If you are the certificate owner, answer the question – Do you have an account on panel.certum.pl?

If you have an account on <u>panel.certum.pl</u> tick – **Yes, I have an account**, click **Next** and you will be asked to log in to your account. The description of certificate revocation with the use of an account is described in a separate instruction.

If you are the certificate owner and do not have an account on <u>panel.certum.pl</u> select - **No, I do not** have an account.
